

FLYING CROP DUSTERS BY-LAWS

ARTICLE – 1 - OFFICES

1. The registered office of The Flying Crop Dusters, AMA Charter number 4111 shall be located at 4520 Indian Creek Road, Emmaus, Pa. 18049.
2. The club may also have offices at other places as the officers may from time to time utilize.

ARTICLE – 2 – MEMBERS

1. Prospective members of the FCD must have current membership in the Academy of Model Aeronautics.
2. Prospective members shall be approved by the club officers prior to being accepted into the club.
3. A majority vote of the officers shall rule.
4. Membership in the FCD is open to all, regardless of race, age, sex or creed.
5. Membership in the FCD shall be limited to twelve (15) senior members. There is no limit for junior members.
6. The club officers may determine the amount of the one-time returnable fee payable upon the termination of membership, the subsequent filling of the vacancy and the annual dues payable by the members.
7. The club officers, by majority vote, may suspend or remove any member for just cause after an appropriate meeting and, may in addition, terminate the membership of any member who becomes ineligible for membership, or suspend or expel any member that is in default in the payment of any assessment.

ARTICLE – 3 – MEETINGS OF MEMBERSHIP

1. Meetings of the club members shall be held at such places that are within easy access to the majority of the membership.
2. The annual meeting of the club members shall be held on a Saturday in late February or early March at a time and place to be determined later. If this date is not acceptable to have a majority, then an alternate Saturday will be selected.
3. Special meetings of the members and the club officers may be called at any time by the President or one of the club officers. The members shall be notified in sufficient time to be able to attend.

ARTICLE – 4 – CLUB OFFICERS

1. The FCD club officers shall be chosen by the club membership, and shall include a President, Vice President, Secretary, Treasurer, Safety Officer and any other officers that the needs of the club may require. They shall hold their offices for a term of one year and shall have the authority to perform such duties as outlined in the By-laws and FCD Safety Rules and Regulations.

ARTICLE – 5 – MISCELLANEOUS

1. A timely newsletter will be prepared and sent to the club membership. It will be sent via e-mail or U.S. mail. It shall contain any item of interest to be addressed at the next club meeting. It will include the time and location of the next club meeting.
2. All members are responsible for adhering to the FCD club By-laws and Safety Rules and Regulations. When participating in club activities, the members are expected to conduct themselves in a manner conducive to good sportsmanship.

ARTICLE – 6 – AMENDMENTS TO BY-LAWS

1. By-laws may be adopted, amended or repealed by the current membership by at least a majority of the votes of all members present at a regular or special meeting convened after timely prior notice has been given to the members for the aforementioned purpose.
